The Security Deposit will not be refunded if you cancel your slip application after 30 days. If your application is denied, or you cancel the reservation, the Security Deposit will be refunded to you (less the \$25 application fee). If you become a tenant, the Security Deposit is held until your final departure from the Marina and will be refunded, less any balance owed to the Marina at that time. It will NOT be applied towards your last month's rent.

I am aware that giving false information and/or concealing information may result in revoking my privilege as a tenant at the Chula Vista Marina.
